STUDENT CIRCULAR NO. 2/2022

STUDENT MOVEMENT INSTRUCTIONS FOLLOWING THE COVID-19 SITUATION UNIVERSITI TEKNOLOGI MALAYSIA (UTM)

Please be informed that following the increase in the number of Covid-19 cases on campus, Kulai District Health Office under Act 1988 Section 18 (1) (f) CDC has ordered the extension of the movement restriction period to some blocks currently being subject to the restriction, and the closure of some additional new blocks in UTM Johor Bahru campus, bringing about restrictions on the in and out movement of the blocks **starting from 12 to 16 February 2022, and the release of the restrictions is subject to risk assessment by Kulai District Health Office.** Accordingly, with reference to Student Circular No 1/2022 and the notification on Movement at Residential Colleges, UTM Johor Bahru dated 12 February 2022 as well as the current situation as informed by Kulai District Health Office, the University has agreed to extend the restriction on movement of students in and out of campus as follows:

- All in and out movements of the blocks placed under movement restrictions are
 NOT PERMITTED until each block's quarantine period ends.
- Permission to enter the campus for the purpose of stay is SUSPENDED until 28
 February 2022 or until further notice.
- (iii) Should there be a need for students to enter the campus for the purpose of stay during the period, students are required to conduct the RTK Saliva Self-test and undergo isolation at the Isolation Center Block G08 (for male students) and Block G05 (female students). The isolation period is five (5) days for those who already had the booster dose and seven (7) days for those who completed two doses of vaccination. Students should bear all food and beverage costs during the isolation period.
- (iv) Item (iii) is only for students who return to blocks that are not subject to the movement restrictions.

These instructions are subject to changes and instructions from the National Security Council (MKN) from time to time.


